 - 2. Organize and present opportunities so that TPC members know how they can serve in the church and community.
 - **3.** Encourage TPC members to become mentors and reach out to other members, to the neighborhood and to the community.
 - 4. Create a spirit-filled congregation at TPC that is the workmanship of God.
 - **5.** Create a welcoming, pleasing and attractive TPC environment.
 - 6. Provide spiritually stimulating worship at TPC that glorifies God, grows disciples and empowers us

- to serve others.
- 7. Educate and encourage TPC members as to how they may also contribute to the Presbyterian Church (USA) Foundation.
